1. Ethio telecom invites all interested and eligible bidders by this **National Competitive Bid** for the procurement of **Medical Laboratory Equipment RFQ No. 3559022, 1** to sign a contract agreement with the finally awarded bidder(s).
The bid remains floating **from August 14, 2017 to September 3, 2017**.

2. All interested bidders are expected to fulfill the requirements stated here below:
 - a) Availability of bid security;
 - b) Availability of Letter of Authorization to sign the bid offers;
 - c) Anti-bribery pledge form; (as per the sample form of in the bidding document)
 - d) Bidders should have a valid and renewed trade license for the year 2009EC.
 - e) Bidders should be VAT registered.
 - f) Compliance statement sheet.
