2. All interested bidders are expected to fulfill the Requirements stated herebelow:
 - a) Bid Security;
 - b) Availability of Letter of Authorization to sign the bid offers;
 - c) Availability of manufacturer authorization letter from the manufacturer for the proposed solution (software and hardware component);
 - d) Bidders should have a valid and renewed trade license for the year (for local bidders);
 - e) Bidders should have VAT registration certificate (for local bidders);
 - f) Tax clearance certificate (for local bidders);
 - g) Anti-bribery pledge form
 - h) Other requirements of the bidding document
3. All bids must be accompanied by a bid security in the amount of **BIRR 100,000.00 (Birr one Hundred Thousand only) or equivalent amount in USD/Euro/Pound sterling**.
