

**Invitation to National Competitive Bid**

2. Interested all local bidders are expected to fulfill the Requirements stated here below.

  - b) Letter of Authorization to the person who have responsibility to sign the bid offers;
  - c) Anti-bribery pledge form; (as per the sample form attached with the bidding document)
  - d) Bidders should submit valid and renewed trade license for the year 2009 E.C.
  - e) Bidders should Submit commercial registration certificate
  - f) Bidders should submit Professional audit license renewed for 2009 E.C
  - g) Bidders should provide Tax Payer Identification (TIN) and VAT registration certificate
  - h) Legal establishment of the company (including Joint venture if any)

- 3.2 The Bank that issues the bond as per 3.1 (c) here above shall unequivocally guarantee to pay the purchaser immediately upon the first written demand of payment. The Purchaser's written demand of payment shall not be subject to any condition whatsoever.
