Ethio Telecom invites all interested and eligible bidders by this national competitive Bid (NCB) for the procurement of building maintenance at semera in Telecom Sector'. Tender No. (RFQ No. 3579056).

1. Interested all local & foreign bidders are expected to fulfill the Requirements stated here below.

- b) Availability of Letter of Authorization to sign the bid offers;
- c) Anti-bribery pledge form; (as per the sample form of in the bidding document)
- d) Bidders should have a valid and renewed trade license for the year.
- e) Bidders should be VAT registered.
- f) Compliance statement
- g) Bidders should have a valid and renewed certificate of competence with category of GC/BC 5 and above issued by Ministry of Urban development, Housing and Construction or respective regional body.
