- e) Bidders should have a valid and renewed trade license for the year;

3. All Bids must be accompanied by a bid security in the amount of **Birr 100,000.00 (Birr One Hundred Thousand)**: if the bidder participate partially **Birr 60,000.00(Birr Sixty Thousand)** for **Cable Locator & Birr 40,000 .00 (Birr Forty Thousand)** for **TDR Cable Fault Locator**.

3.1 The bid bond shall be furnished in one of the following forms: -
