- Bidders should have a valid and renewed trade license for the year;
- Bidders should have VAT registration certificate.

2. All bids must be accompanied by a bid security in the amount of **Birr 30,000 birr (Birr Thirty only) for VSAT and SATELLITE TOOLS 2**.
