All Bids must be accompanied by a bid security in the amount of **Birr 30,000 (Birr thirty thousand only)** for **Special Oxyacetylene Welding** and **Birr 20,000 birr (Birr twenty thousand only)** for **Stud Welding Tools** and a total of **Birr 50,000.00 (Birr fifty Thousand Only)** for **both Oxyacetylene Welding & Cutting Tools Box complete with cylinders and trolley and Stud Welding tool**.
