1. Interested all local bidders are expected to fulfill the **Eligibility Requirements** stated here below.
  - a) Valid business license indicating the stream of business in which the bidder is engaged
  - b) Bid security as required (ETB 400,000.00)
  - c) Valid certificate of competence issued by Federal Ministry of Urban Development, Housing and Construction or respective regional body.
  - d) VAT Registration certificate issued by the tax authority
  - e) Valid tax clearance certificate issued by the tax authority
  - f) Audit report of the last five years performed by external certified auditor
2. All bids must be accompanied by a bid security in the amount of **Birr 400,000.00 (Birr four hundred Thousand only)**.
