Ethio telecom invites all interested and eligible bidders by this **National Competitive Bid** for the procurement of **General, sanitary and Electrical maintenance with delivery service through Master frame agreement bases RFQ No. 3600046** to sign a contract agreement with the finally awarded bidder(s).

The bid remains floating **from June 5, 2017 to June, 27, 2017**.

2. All interested bidders are expected to fulfill the requirements stated here below:

 - d) Bidders should have VAT registration certificate.
 - e) Anti-bribery pledge form.
 - f) Availability of Compliance statement for the technical specification and the bid document.
