Ethio telecom invites all interested and eligible bidders by this **National Competitive Bid** for the procurement of **Regional Office Building Construction at Jimma with RFQ No. 3601063** to sign a contract agreement with the finally awarded bidder(s). The bid remains floating **from October 23, 2017 to November 23, 2017**.

Bid documents can be obtained from ethio telecom head office, room no. 201 during office hours upon payment of a non-refundable fee of Birr **200.00 (Birr two hundred only)**.

2. All interested bidders are expected to fulfill the requirements stated here below:
  - a) Bid Security;
  - b) Availability of Letter of Authorization to sign the bid offers;
  - c) Bidders should have a valid and renewed trade license for the year
  - d) Bidders should have VAT registration certificate
  - e) Bidders should have a renewed competence certificate from Ministry of Urban Development & Housing Construction or/and respective regional government organ, grade category GC/BC grade 1
  - f) Anti-bribery pledge form
  - g) Other requirements of the bidding document

All bids must be accompanied by a bid security in the amount of Birr 250,000.00 (Birr two hundred fifty thousand only)
