**REQUIREMENTS**

1. Ethio telecom invites all interested and eligible bidders by this **National Competitive Bid** for the procurement of **Towing Service for Light Vehicles and Light Trucks with RFQ No. 3602024** to sign a contract agreement with the finally awarded bidder(s). The bid remains floating **from June 26, 2017 to July 17, 2017**.

Bid documents can be obtained from ethio telecom head office, room no. 201 during office hours upon payment of a non-refundable fee of Birr **30.00 (Birr thirty only)**. All interested bidders are expected to fulfill the requirements stated here below:

- a. Availability Bid Security

  - c. Bidders should have a valid and renewed trade license for the year
  - d. Bidders should have VAT registration certificate
  - e. Tax Clearance Certificate
  - f. Anti-bribery pledge form
2. All bids must be accompanied by a bid security in the amount of Birr 10,000.00 (Birr ten thousand only). The bid bond shall be furnished in one of the following forms:
    - a) Certified Cheque /CPO issued by a recognized domestic bank or
    - b) Bond issued by and/or confirmed through a recognized/reputable domestic bank.
    - c) Cash Deposit Advise (if the amount is up to Birr 50,000.00)
  - 2.1. The bank that issues the bond as per 2 (b) hereabove shall **unequivocally guarantee to pay the purchaser immediately upon the first written demand of payment**. The purchaser's written demand of payment shall not be subject to any condition whatsoever.
