2. All interested bidders are expected to fulfill the requirements stated herebelow.

 - b) Availability of letter of authorization to sign the bid offers;
 - c) Anti-bribery pledge form (as per the sample form of in the bidding document);
 - d) Bidders should have a valid and renewed trade license for the year;
 - e) Bidders should be VAT registered;
 - f) Compliance statement ;
 - g) Availability of sample.
