REQUIREMENTS

1. Ethio telecom invites all interested and eligible bidders by this **National Competitive Bid** for the procurement of **Construction of Finishing and Maintenance Work at Sar Bet Shop, Akaki Shop, Airport Shop and Jomo Shop RFQ No. 3603038** to sign a contract agreement with the finally awarded bidder. The bid remains floating **from July 10, 2017 to July 24, 2017**.

Bid documents can be obtained from ethio telecom Head Office, Room No. 201 during office hours upon payment of a non-refundable fee of Birr **100.00 (Birr One Hundred only)**.

2. All interested bidders are expected to fulfill the requirements stated here below:
 - a) Availability of bid security;
 - b) Availability of letter of authorization to sign the bid offers;
 - c) Anti-bribery pledge form; (as per the sample form of in the bidding document);
 - d) Bidders should have a valid and renewed trade license issued by Ministry of Urban Development & Housing Construction for the year or the respective region;
 - e) Bidders should be VAT registered;
 - f) Renewed certificate of competency;
 - g) The grade category should be GC/BC Grade 6 and above.
3. All bids must be accompanied by a bid security in the amount of **Birr 30,000.00 (Birr thirty Thousand only)**.
 - 3.1. The bid bond shall be furnished in one of the following forms:
 - a) Certified Cheque/CPO issued by a recognized domestic bank or;
 - b) Bond issued by and/or confirmed through a recognized/reputable domestic bank;
 - c) Cash deposit advice.
 - 3.2. The bank that issues the bond as per 3.1 (b) hereabove shall **unequivocally guarantee to pay the purchaser immediately upon the first written demand of payment**. The purchaser's written demand of payment shall not be subject to any condition whatsoever.
 - 3.3. The bond issuing bank shall clearly incorporate the content stated under the clause hereabove on the issued bond.
