2. All interested bidders are expected to fulfill the requirements stated here below:

 - c) Bidders should have a valid and renewed trade license for the year
 - d) Bidders should have VAT registration certificate
 - e) Anti-bribery pledge form
 - f) Renewed certificate of competence letter from Ministry of Urban Development & Housing Construction and/or Oromiya regional office grade category must be GC/BC 6 & above Compliance statement
