All local firms organized and licensed under the laws of Ethiopia that qualify to bid are invited to participate in this invitation to bids and have to fulfill the following requirements in addition to the above mentioned requirements.

- Bidders should have a valid and renewed trade license for the year;
 - Bidders should have VAT registration certificate.
3. All Bids must be accompanied by a bid security in the amount of **Birr 100,000.00** (Birr One Hundred Thousand only) for the supply of **194MHz Satellite Transponder Lease service for 3(three) years**.

3.1. The bid bond shall be furnished in one of the following forms: -
