 - c) Anti-bribery pledge form
 - d) Bidders should have a valid and renewed trade license for the year;
 - e) Bidders should be VAT registered.
 - f) Bidders should submit 3 meters of sample for each Cable Plastic type 10px2x0.4 and 20px2x0.4
- 3) All Bids must be accompanied by a bid security in the amount of **Birr 30,000.00 (Birr Thirty Thousand)**.
