Ethio telecom invites all interested and eligible bidders by this **National Competitive Bid (NCB)** for the procurement of **Maintenance toolkit like, Blower Cordless, Rotary Hammer, and Genuine Toolkit** through master frame agreement with **RFQ No. 3614190** to sign a contract agreement with the finally awarded bidder(s). The bid remains floating from **December 11, 2017 to January 4, 2018**.

2. All interested bidders are expected to fulfill the requirements stated here below:
 - a) Bid Security;
 - b) Availability of Letter of Authorization to sign the bid offers;
 - c) Bidders should have a valid and renewed trade license for the year;
 - d) Bidders should have VAT registration certificate;
 - e) Anti-bribery pledge form.
3. All bids must be accompanied by a bid security amount of **Birr 10,000.00 (Birr Ten Thousand only) only for Genuine Toolkit**.
 - 3.1. The bid bond shall be furnished in one of the following forms:
 - a) Certified cheque/CPO issued by a recognized domestic bank or;
