Ethio telecom invites all interested and eligible bidders (**GC/BC grade 6 & above**) by this **national Competitive Bid** for the procurement of **Maintenance Work of Core Sites at Mekele with RFQ NO. 3615363** to sign a contract agreement with the finally awarded bidder(s). The bid remains floating **from Jan 01, 2018 to Jan 22, 2018**.

2. All interested bidders are expected to fulfill the requirements stated here below:
  - a) Bid Security **40,000.00** ETB.
  - b) Availability of Letter of Authorization to sign the bid offers;
  - c) Bidders should have a valid and renewed trade license for the year 2009/10
  - d) Bidders should have VAT registration certificate
  - e) Anti-bribery pledge form
  - f) Renewed certificate of competence from Ministry of Urban Development & Housing construction or Addis Abeba City administrative Office GC/BC grade 6 & above
  - g) Compliance statement
3. All Bids must be accompanied by a bid security in the amount of Birr **40,000.00 (Birr Forty Thousand only)**
