Ethio telecom invites all interested and eligible bidders (**CA/CAE Grade 3 & above**) by this **National Competitive Bid** for the procurement of **Design, Consultancy and Supervision Services of Regional Office Building at Assosa** with **RFQ NO. 3617207, 1** to sign a contract agreement with the finally awarded bidder(s).

The bid remains floating **from March 6, 2018 to March 27, 2018 until 5:00PM.**
