Ethio telecom invites all interested eligible Bidders by this National Competitive Bid (NCB) for the procurement of “**Design and Consultancy service for Regional Office Building & Zonal Office Building at Gonder & South Addis Ababa Zone (SAAZ) RFQ 3618234**” Bid Documents can be obtained from ethio telecom’s Head Office, Room No. 201 during Office hours (Monday to Friday) upon payment of a non-refundable fee of Birr 100.00 (Birr one hundred only).

1. Interested all local bidders are expected to fulfill the Eligibility Requirements stated here below.

**1.1 Eligibility Requirements**

- a) Availability of Bid Security 60,000 ETB;
- b) Renewed Business license for the year 2010;
- c) Renewed Certificate of Competence CA/CAE Grade 1 and above
- d) Bidders should be VAT registered certificate;
- e) Letter of Authorization to sign the bid offers;
- f) Availability of anti-bribery pledge form;
- g) Availability of Compliance statement

2. All bids must be accompanied by a bid security in the amount of **Birr 60,000.00 (Birr fifty thousand only)**

2.1 The bid bond shall be furnished in one of the following forms: -
