2. All interested bidders are expected to fulfill the following **Eligibility requirements** stated here below:

 - b) Availability of Letter of Authorization to sign the bid offers;
 - c) Availability of manufacturer authorization letter from the manufacturer or authorized dealer to resell or distribute the goods.
 - d) Bidders should have a valid and renewed trade license for the year
 - e) Bidders should have VAT registration certificate
 - f) Anti-bribery pledge form
 - 2.1. **All Bids must be accompanied by a bid security in the amount of Birr 40,000.00 (Forty Thousand only) for both items. And for those bidders who want to participate only in portable Type under Vehicle Including Camera**

with Display Mirror the bid security amount shall be Birr 15,000.00 (Fifteen thousand birr) and Birr 25,000.00 (Twenty five thousand birr) for Handheld Metal Detector.

- 2.2. The bid bond shall be furnished in one of the following forms:-

 - b) Bond issued by and/or confirmed through a recognized/reputable domestic bank.
