REQUIREMENTS

1. Ethio telecom invites all interested and eligible bidders (GC/BC 6 & above) by this **National Competitive Bid** for the procurement of **Construction of Shop at Bole International Airport Terminal 2 with RFQ No. 3623244** to sign a contract agreement with the finally awarded bidder(s). The bid remains floating **from March 20, 2018 to April 10, 2018**.

Bid documents can be obtained from ethio telecom head office, room no. 201 during office hours upon payment of a non-refundable fee of Birr **100.00 (Birr One Hundred only)**.

2. All interested bidders are expected to fulfill the requirements stated here below:
 - a) Bid Security valid for 148 days starting from bid opening time;
 - b) Bidders should have a valid and renewed trade license for the year;
 - c) Bidders should have VAT registration certificate;
 - d) Bidders should have a renewed competence certificate from Ministry of Urban Development & Housing Construction or/and Addis Abeba City Administrative Office, grade category GC/BC grade 6 & above;
 - e) Bid submission sheet;
 - f) Letter of authorization to sign the bid;
 - g) Bidders should have valid tax clearance certificate for the year.

All bids must be accompanied by a bid security in the amount of Birr 30,000.00 (Birr Thirty Thousand only)

- 2.1. The bid bond shall be furnished in one of the following forms:
 - a) Certified Cheque /CPO issued by a recognized domestic bank or
 - b) Bond issued by and/or confirmed through a recognized/reputable domestic bank.
- 2.2. The bank that issues the bond as per 2.1 (b) hereabove shall **unequivocally guarantee to pay the purchaser immediately upon the first written demand of payment**. The purchaser's written demand of payment shall not be subject to any condition whatsoever.
- 2.3. The bond issuing bank shall clearly incorporate the content stated under the clause here above on the issued bond.
