Ethio telecom invites all interested eligible bidders by this National Competitive Bid (NCB) for the procurement of different marketing trainings (RFQ No. 3624227).

1. Bid documents can be obtained from ethio telecom's head office, room no. 201 during office hours (Monday to Friday) upon payment of a non-refundable fee of Birr **100.00 (Birr one hundred only)**.
2. Interested all local bidders are expected to fulfill the eligibility requirements stated here below.

a. Eligibility Requirements:

- a) Availability of Bid Security as required;

 - c) Availability of anti-bribery pledge form;
 - d) Renewed trade license for this year;
