The RFQ remains floating from ***April 11, 2018 to May 02, 2018***.

 - c) Bond issued by and/or confirmed through a recognized/reputable domestic bank.

 - 1.3 The bond issuing bank shall clearly incorporate the content stated under Clause 3.2 here above on the issued bond.
