Ethio telecom invites all interested and eligible bidders by this **national Competitive Bid** for the procurement of **Light and Heavy Curtain with RFQ NO. 3628174** to sign a **Frame Agreement** for one year with possible extension up to three years with the finally awarded bidder(s). The bid remains floating **from April 16, 2018 to May 07, 2018**.

Bid documents can be obtained from ethio telecom head office, room no. 201 during office hours upon payment of a non-refundable fee of Birr **100.00 (Birr One Hundred only)**.

2. All interested bidders are expected to fulfill the requirements stated here below:
 - a) Bid Security;
 - b) Availability of Letter of Authorization to sign the bid offers;
 - c) Bidders should have a valid and renewed trade license for the year;
 - d) Bidders should have VAT registration certificate;
 - e) Anti-bribery pledge form;
 - f) Compliance statement.
3. All bids must be accompanied by a bid security in the amount of Birr **20,000.00** (Birr twenty thousand only).
 - 3.1 The bid bond shall be furnished in one of the following forms:
 - a. Certified Cheque/CPO issued by recognized domestic bank or;
 - b. Bond issued by and/or confirmed through a recognized /reputable domestic bank
 - c. Cash deposit advise.
 - 3.2 The bank that issues the bond as per 3.1 (b) here above shall unequivocally guarantee to pay the purchaser immediately upon the first written demand of payment. The purchaser's written demand of payment shall not be subject to any condition whatsoever.
 - 3.3 The bond issuing bank shall clearly incorporate the content stated under the clause here above on the issued bond.
