Ethio telecom intends to sign a Master Frame Agreement (MFA) contract for one (1) year with a possibility of extension up to a maximum of 3 years with the finally awarded bidder/bidders. Hence, ethio telecom invites all interested and eligible bidders by this international competitive bid for the procurement of **GSM Fixed Wireless Terminals and 3G Fixed Wireless Terminals with RFQ No. 3612260**. The RFQ remains floating from **November 10, 2017 to December 11, 2017**.
